ORDINANCE \_\_\_\_\_

**AN ORDINANCE WHEREBY THE CITY OF LATHROP, MISSOURI UPDATES AUTHORIZATION FOR RETURNING OF WATER DEPOSITS TO CERTAIN CUSTOMERS WHO MEET THE DEFINED CRITERIA FOR PAYMENT OF UTILITY BILLS.**

**WHEREAS**, The Board of Aldermen believes it is in the best interests of the City to return water deposits to certain customers of the City of Lathrop, Missouri; and,

**WHEREAS**, the Board of Aldermen desires to authorize returning the deposit fee to customers meeting the defined criteria; and,

**NOW THEREFORE**, BE IT ORDINATED BY THE BOARD OF ALDERMEN OF LATHROP, MISSOURI AS FOLLOWS:

**Section 1.** Section 700.070 – Bill Payment Guarantees and Deposit. Add the provision that water deposits shall be returned to those customers who are homeowners or renters with a record of sixty (60) consecutive months of payments without a late fee or penalty on their utility bill.

**Section 2.** Section 700.080 – Any customer that has their service disconnected due to late payments and does not have a current water deposit will be required to establish a water deposit prior to reconnection.

**Section 3.** This ordinance shall go into effect immediately after its passage by the Board of Aldermen of the City of Lathrop, Missouri.
