ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF LATHROP, MISSOURI, TO ADOPT THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2023.

WHEREAS a budget has been proposed to the Board of Aldermen; and

WHEREAS the Board of Aldermen have reviewed such budget and wish to adopt it as the budget for the fiscal year ending June 30, 2023.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI AS FOLLOWS:

Section 1. The proposed budget, as attached hereto and made a part hereof as if fully set forth herein, is adopted.

Section 2. Funds are hereby appropriated for the expenditures set forth in said budget.

Section 3. The Mayor and Board of Aldermen have signed the adopted budget, and a signed copy shall be maintained in the City’s records and be available for public inspection.

Section 4. This Ordinance shall be in effect from the date of passage and approval of the Board of Aldermen.
