ORDINANCE \_\_\_\_\_

**AN ORDINANCE OF THE CITY OF LATHROP, MISSOURI TO AUTHORIZE AN INCREASE IN WATER RATES EFFECTIVE WITH THE AUGUST 2017 METER READING TO HELP OFFSET WHOLESALE WATER RATE INCREASE AND AN INCREASE IN OPERATING COSTS.**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI, AS FOLLOWS:**

**WHEREAS**, the Board of Aldermen finds it necessary to increase water rates to cover the increased cost of water purchased from the Kansas City Water Services Department and an increase in the operating costs; and

**WHEREAS**, the Board of Aldermen desires that the City of Lathrop maintain a sound financial condition for the water system; and

**NOW THEREFORE**, be it ordained by the Board of Aldermen of the City of Lathrop, Missouri, as follows:

**Section 1** Revise water rates as listed in the table below:

Water metered within the City Limits –

First 1000 Gallons	Over 1000 Gallons	Surcharge
\$11.45	\$9.20 per 1000 Gallons	\$0.00

Water metered outside the City Limits –

First 1000 Gallons	Over 1000 Gallons	Surcharge
\$13.52	\$10.03 per 1000 Gallons	\$18.00

**Section 2** Effective Date. This Ordinance shall be in full force and effect from and after the day of its passage and approval.
