**AN ORDINANCE APPROVING THE CITY OF LATHROP, MISSOURI 2023 TAX LEVY AS ESTABLISHED AT THE TAX LEVY PUBLIC HEARING.**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI, AS FOLLOWS:**

**WHEREAS**, The City of Lathrop is required to establish a tax levy by September 1<sup>st</sup> of each calendar year; and,

**Whereas**, the Board of Aldermen of the City of Lathrop, Missouri held a public hearing on August 15, 2023 to establish the 2023 tax levy; and,

**NOW THEREFORE**, be it ordained by the Board of Aldermen of the City of Lathrop, Missouri, as follows:

1. The tax levy shown is the levy that was agreed upon by the Board of Aldermen during the Public Hearing on August 15, 2023. The Board of Aldermen approve the following figures for the 2023 tax levy:

Category	Amount
General Fund	\$0.5618
Park Fund	\$0.1478
Debt Service Fund	\$0.4556
<b>Total</b>	<b>\$1.1652</b>

2. The ordinance approving the 2023 tax levy shall be in full force and effect as of September 1, 2023 upon approval by the Board of Aldermen of the City of Lathrop.
