ORDINANCE _____

AN ORDINANCE APPROVING THE CITY OF LATHROP, MISSOURI 2019 TAX LEVY AS ESTABLISHED AT THE TAX LEVY PUBLIC HEARING.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI, AS FOLLOWS:

WHEREAS, The City of Lathrop is required to establish a tax levy by September 1st of each calendar year; and,

Whereas, the Board of Aldermen of the City of Lathrop, Missouri held a public hearing on August 20, 2019 to establish the 2019 tax levy; and,

NOW THEREFORE, be it ordained by the Board of Aldermen of the City of Lathrop, Missouri, as follows:

1. The tax levy shown is the levy that was agreed upon by the Board of Aldermen during the Public Hearing on August 20, 2019. The Board of Aldermen approve the following figures for the 2019 tax levy:

Category	Amount
General Fund	\$0.5906
Park Fund	\$0.1554
Debt Service Fund	\$0.5700
Total	\$1.3160

2. The ordinance approving the 2019 tax levy shall be in full force and effect as of September 1, 2019 upon approval by the Board of Aldermen of the City of Lathrop.
