
**11. Aldermen Comments**

Alderman Porter Hensen brought up issues that he was ask in the community concerning the Mayor's taxes and the recent civil judgement. After discussion, no additional action was taken.


Alderman Coetta Whiteley had questions concerning code violations in the City. Bob had said one violation brought up was in process and he would follow on the other concern.
