ORDINANCE _____

AN ORDINANCE REVISING THE CITY OF LATHROP, MISSOURI 2018 TAX LEVY AS ESTABLISHED AT THE TAX LEVY PUBLIC HEARING AND REPEALING ORDINANCE 1315.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI, AS FOLLOWS:

WHEREAS, The City of Lathrop is required to establish a tax levy by September 1st of each calendar year; and,

Whereas, the Board of Aldermen of the City of Lathrop, Missouri held a public hearing on August 21, 2018 to establish the 2018 tax levy; and,

NOW THEREFORE, be it ordained by the Board of Aldermen of the City of Lathrop, Missouri, as follows:

1. The tax levy shown is the levy that has been approved by the Missouri State Auditor and is less than the agreed to Debt Service Levy on August 21, 2018. The Board of Aldermen hereby approve the following figures for the 2018 tax levy:

Category	Amount
General Fund	\$0.5906
Park Fund	\$0.1554
Debt Service Fund	\$0.5057
Total	\$1.2517

2. The ordinance approving the 2018 tax levy shall be in full force and effect as of September 1, 2018 upon approval by the Board of Aldermen of the City of Lathrop.
