ORDINANCE NO. _____

AN ORDINANCE CALLING FOR A GENERAL ELECTION FOR THE CITY OF LATHROP, MISSOURI TO BE HELD ON TUESDAY APRIL 2, 2019 FOR THE PURPOSE OF SUBMITTING TO THE VOTERS, CANDIDATES FOR MAYOR FOR A TERM OF TWO YEARS, ONE ALDERMAN FROM WARD I (SOUTH WARD) FOR A TERM OF TWO YEARS, AND ONE ALDERMAN FROM WARD II (NORTH WARD) FOR A TERM OF TWO YEARS.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI AS FOLLOWS:

Section 1. That the general election of the City of Lathrop, Missouri shall be held on April 2, 2019 for the purpose of submitting to the voters of the city candidates for Mayor for the term of two years, one Alderman from Ward I (South Ward) for a term of two years, and one Alderman from Ward II (North Ward) for a term of two years.

Section 2. That the General Election will be held at the following place in said City: Polling place for Ward I and Ward II, Goppert Community Center, 406 Elm Street, Lathrop, MO.

Said election will be held and the polling place for same will be open between the hours of 6:00 o'clock in the morning and 7:00 o'clock in the evening.

Section 3. The Clerk of the City of Lathrop, Missouri is responsible for filing Notice of General Election by causing to be published in The Clinton County Leader, a newspaper printed, published and in general circulation in the City of Lathrop, Missouri, a Notice of General Election in the following form, to-wit:

Notice of City Election

In accordance with the Missouri Comprehensive Election Act of 1977, and pursuant to the provisions of Chapters 70.010, et seq., and 130.010 et seq., Revised Statutes of Missouri, I hereby give notice that the General Election for the City of Lathrop will be held on Tuesday, April 2, 2019, for the purpose of electing the following city officials:

Mayor for the term of two years.

One Alderman from Ward I (South Ward) for a term of two years.

One Alderman from Ward II (North Ward) for a term of two years.

Polling place for Ward I and Ward II, Goppert Community Center, 406 Elm Street. Polls will be open from 6:00 AM until 7:00 PM.

All candidates shall file with the City Clerk beginning December 11, 2018, 8:00 AM and ending January 15, 2019. Hours to file are 8:00 AM to 5:00 PM, Monday through Friday. All qualified electors of the City of Lathrop shall be entitled to vote at said election.

Section 4. This ordinance shall be in full force and effect from and after the date of its passage by the Board of Alderman of the City of Lathrop, Missouri.
