**AN ORDINANCE IMPOSING AN ADDITIONAL ONE PERCENT SALES TAX ON DOMESTIC UTILITIES IN THE CITY OF LATHROP, MISSOURI.**

**WHEREAS**, pursuant to Ordinance 1364 the Board of Aldermen ordered an election to be held in the City on April 4, 2023, for the purpose of submitting to the voters of the City the following question:

Shall the city of Lathrop, Missouri, impose a city sales tax of 1%, with such funds to be used for the improvement of streets?

**WHEREAS**, the votes cast at said election were duly canvassed as provided by law, and it was found and declared that a majority of the qualified voters of the City voting at said election on said question voted in favor of the imposition of said sales tax; and

**WHEREAS**, the City enacted Ordinance 1368 on May 16, 2023, which applied the 1% sales tax generally within the City; and

**WHEREAS**, the City wishes to apply the additional 1% sales tax to domestic utilities under R.S.Mo. 144.032.

**NOW, THEREFORE, BE IT ORDAINED BY BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI AS FOLLOWS:**

**SECTION 1.** The Board of Aldermen hereby authorizes the City to impose an additional general revenue sales tax of 1% on metered water services; electricity and electrical current; natural, artificial and propane gas; wood; coal; and home heating oil, pursuant to R.S.Mo. 94.510 and R.S.Mo. 144.032, with such funds to be designated for street improvements.

**SECTION 2.** The City Clerk shall forward to the Missouri Department of Revenue a certified copy of this Ordinance, Ordinance 1364, and Ordinance 1368, and certifications of the election results on the question for the April 4, 2023 election.

Read twice and passed by a majority vote of the Board of Aldermen of the City of Lathrop, Missouri, this 16th day of January, 2024.
