**AN ORDINANCE CALLING FOR A GENERAL ELECTION FOR THE CITY OF LATHROP, MISSOURI TO BE HELD ON TUESDAY APRIL 3, 2018 FOR THE PURPOSE OF SUBMITTING TO THE VOTERS, CANDIDATES FOR ONE ALDERMAN FROM WARD I (SOUTH WARD) FOR A TERM OF TWO YEARS, AND ONE ALDERMAN FROM WARD II (NORTH WARD) FOR A TERM OF TWO YEARS.**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LATHROP, MISSOURI AS FOLLOWS:**

**Section 1.** That the general election of the City of Lathrop, Missouri shall be held on April 3, 2018 for the purpose of submitting to the voters of the city candidates for one Alderman from Ward I (South Ward) for a term of two years, and one Alderman from Ward II (North Ward) for a term of two years.

**Section 2.** That the General Election will be held at the following place in said City: Polling place for Ward I and Ward II, Goppert Community Center, 406 Elm Street, Lathrop, MO.

Said election will be held and the polling place for same will be open between the hours of 6:00 o'clock in the morning and 7:00 o'clock in the evening.

**Section 3.** The Clerk of the City of Lathrop, Missouri is responsible for filing Notice of General Election by causing to be published in The Clinton County Leader, a newspaper printed, published and in general circulation in the City of Lathrop, Missouri, a Notice of General Election in the following form, to-wit:

### **Notice of City Election**

In accordance with the Missouri Comprehensive Election Act of 1977, and pursuant to the provisions of Chapters 70.010, et seq., and 130.010 et seq., Revised Statutes of Missouri, I hereby give notice that the General Election for the City of Lathrop will be held on Tuesday, April 3, 2018, for the purpose of electing the following city officials:

One Alderman from Ward I (South Ward) for a term of two years.

One Alderman from Ward II (North Ward) for a term of two years.

Polling place for Ward I and Ward II, Goppert Community Center, 406 Elm Street. Polls will be open from 6:00 AM until 7:00 PM.

All candidates shall file with the City Clerk beginning December 12, 2017, 8:00 AM and ending January 16, 2018. Hours to file are 8:00 AM to 5:00 PM, Monday through Friday. All qualified electors of the City of Lathrop shall be entitled to vote at said election.

**AN ORDINANCE BY THE CITY OF LATHROP, MISSOURI TO CORRECT ORDINANCE 1300 TO READ "94.500 TO 94.577 RSMo" FOUR PLACES TO BE COMPATIBLE WITH ORDINANCE 1164 CORRECTED IN ORDINANCE 1178 BOTH PASSED IN 2008 AND ALLOW A CONTINUATION OF THE ONE-HALF PERCENT SALES TAX APPROVED BY A MAJORITY OF THE VOTERS OF THE CITY OF LATHROP IN THE GENERAL ELECTION HELD ON AUGUST 8, 2017.**

**WHEREAS**, the Board of Aldermen of the Lathrop, Missouri desires to correct Ordinance 1300 by changing the reference to RSMo 94.570 to **RSMo 94.577** to be compatible with ordinance 1164 corrected in ordinance 1178, and

**WHEREAS**, the question imposed by Ordinance 1300 has been approved by a majority of the qualified voters of the city voting thereon and the subject correction has no effect on the question,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF LATHROP, MISSOURI AS FOLLOWS:

**Section 1.** Amend Ordinance 1300 to change all references to RSMo 94.570 to RSMo 94.577.

**Section 2.** The Effective Date, This Ordinance shall be in full force and effect from and after the day of its passage and approval.
