

**Mayor & Board of Aldermen

1. Call to Order

Mayor Jennifer Morrison called the regular meeting of the Board of Aldermen to order at 6:00 p.m., Tuesday, September 21, 2021 in the Betty Brazelton Community Center at City Hall. Mayor Morrison led the Pledge of Alliance.

2. Roll Call

3. Approve Agenda


18. Executive Session – Litigation RSMO 610.021 (1)
